Summary of RSC Meeting decision points

- The RSC Eligibility Performance Assessment (EPA) and improvement plan were endorsed by the RSC.
- The choice of topics presented by the Independent Monitoring Panel (IMP) for their work in 2020 is appropriate. These will be further fine-tuned at the RSC Ex-Com meeting planned for June 2020.
- The RSC OR Subcommittee to quickly compose a recommendation to the RSC and the GF on whether the three OR projects that will not be finished by the end of 2020 should be continued.

Meeting introduction

The RSC was convened online due to COVID19 ongoing crisis.

Review and endorsement of the RSC Eligibility Performance Assessment (EPA and Performance Improvement Plan)

The results of RSC self-assessment and draft PIP were presented for discussion/endorsement.

Decision Point:

• The RSC Eligibility Performance Assessment (EPA) and improvement plan were endorsed by the RSC.

Epidemiological updates

Dr Luciano Tuseo, WHO MME Coordinator

An epidemiological update of malaria burden in the GMS was presented.

Discussion:

• The failure of DHA-Piperaquine, which was the first line drug until recently in Viet Nam, has shown the importance to have access to other first line treatment. With Pyramax registration in

Viet Nam the number of P.f. cases is expected to quickly decrease. Resistance monitoring in the adjacent provinces was reassured by NIMPE.

RAI Progress Update (UNOPS)

The overall progress of the RAI2E grant were presented.

Discussion:

• Foci investigation in Cambodia has started in 2020. Its implementation is feasible and ongoing, and the data are being analysed.

Vietnam Presentation

NMCP provided an update on the Country progress against the RAI2E objectives.

Discussion:

- Molecular surveillance of Piperaquine is not being conducted currently, but samples are being collected.
- 0.25 mg primaquine 14 days for *P.v.* treatment is currently deployed.

Lao PDR Presentation

Myanmar Presentation

NMCP provided an update on the Country progress against the RAI2E objectives.

Discussion:

• The provision of malaria services in non-government control areas remains a challenge, also in high endemic areas such as Hpapun. In some areas a 'malaria elimination taskforce' has been established, in collaboration with SMRU and other partners, which are proving to be effective. These initiatives shall continue and be strengthened.

- Security remains a main challenge to provide malaria service in some non-government controlled areas, but through ICMVs and supply chain arrangements, provision of services is mostly in place.
- G6PD testing is being introduced for radical cure of P.v.

Thailand Presentation

NMCP provided an update on the country progress against the RAI2E objectives.

Discussion:

• More details are needed on the coverage of Primaquine radical cure in the treatment of *P.v.* patients in Thailand. Access to care in the deep south remains a concern to be addressed.

IMP Presentation on planned activities for 2020

A summary of IMP activities so far was provided. A list of activities to be conducted in 2020 was proposed to the RSC for discussion.

Discussion and decision point:

- The choice of topics presented for IMP work in 2020 is appropriate. These will be further fine-tuned at the RSC Ex-Com meeting planned for June 2020.
- The IMP will likely recruit in-country consultants in the GMS Countries to continue their field work regardless of COVID related travel restrictions.
- With regards to IMP work on Operational Research, the OR Sub-Committee is expected to formulate guidance on IMP involvement.
- The IMP is requested to conduct an evaluation of the regional component.

Operational Research Update

See UNOPS summary document

UNOPS presented an estimation of the funding required to complete the research that won't be finished during RAI2E. Three projects have been identified: Burnet Institute, UCSF, MORU. If the RSC OR Sub-Committee confirms the importance from a technical point of view of continuing the three studies, the Global Fund will be able to support the continuation of the studies.

Discussion and decision point:

- The RSC OR Subcommittee to quickly propose recommendation to the RSC and the GF on whether the three OR projects that will not be finished by the end of 2020 should be continued.
- The RAI RSC shall be able to quickly adapt their activities to any new evidence generated by OR.
 This would be particularly relevant in case chemoprevention for forest goers prove to be an
 effective intervention.

AOB and next meeting

Preliminary dates for meetings in 2020:

- The next RSC Ex-Com will take place on the 12th of June in Bangkok, pending on the evolving COVID-19 pandemic.
- The next RSC Meeting will take place on $10^{th} 11^{th}$ of November in Hanoi.
- Update from APLMA: the malaria week is being re-scheduled for September/October 2020 in Hanoi or could be back to back with RSC meeting (to be discussed with the RCS Secretariat)
